5.1 AudCom Conventions and FAQ update

Teresa reviewed the updated versions of the AudCom Conventions and FAQs. A lengthy discussion took place regarding the changes to the Conventions and FAQs.

Action item: Teresa shall combine the FAQs into one document and create a table of contents.

A motion was made (Rosdahl) and seconded (Mohla) to approve the "AudCom Conventions for the Review of Standards Committee Policies and Procedures" in Draft SC conv v2. The motion passed with a vote of 11=Yes; 1=Abstain (Reilly).

A motion was made (Rosdahl) and seconded (Mohla) to approve the "AudCom Conventions for the Review of Working Group Policies and Procedures" in Draft WG convention v2. The motion passes unanimously.

6. NEW BUSINESS

6.1. Request for Standards Committee Recognition

No Standards Committee was recognized.

6.2 Update on Expiring P&P for 2024

Teresa provided an update on the outstanding Standards Committees (SC)s that have not submitted a P&P for 2024. There are 2 SCs that have not submitted; however, they have requested an extension and will submit P&Ps by January 2025. The extensions were granted.

Action item: Teresa will provide an update at the March AudCom meeting on expiring SC P&Ps for 2025 and an update on Working Group P&Ps that are outstanding.

6.3 Action item updates

Staff has been working on reviewing the P&P submission process and automation tools for drafting P&Ps. An update will be provided at the March 2025 meeting.

6.4 Other business

Discussions were held on other topics such as:

- Should an additional responsibility item be added to an officer's responsibilities when that officer performs another officer's position. AudCom agreed this was not needed.
- Should AudCom request that more than one WG P&P be required for submittal to AudCom. AudCom felt this was not needed.
- Adding a current status designation within myProject on the submissions detail page for each P&P.

Action item: Teresa will investigate the ability to add this designation and report back at the March AudCom meeting.

The next meeting of AudCom will be a hybrid meeting in Seoul, Republic of Korea (UTC+9) and via Webex. The meeting will take place on 24 March 2025.
